Overview

The Maple Armor Sounder Base offers 520 Hz low frequency audible output to the addressable detector, bases can function as standalone local alarms or integrate into a zone or system alarm, providing synchronized audible output.

This base is engineered to operate with the Series 2 Smoke and Heat detector heads; it does not take an address on SLC.

It provides multiple tone patterns required by NFPA 72 for commercial and residential applications, each with three selectable sound output levels, and could be configured via programming.



Installation


All Series 2 Sounder Bases mount to any standard North American single-gang or octagon electrical boxes.

Wiring


Field wiring is to be completed using the terminal screws on the back of the appliances, and it can accommodate #18 to #12 AWG (0.82 mm² to 3.31 mm²).
